INSTRUCTIONS TO APPLICANTS

1. The New India Assurance Company limited, Mumbai (hereinafter referred to as "NIACL"), invites Request for proposal (hereinafter referred to as "RFP") from agencies for conducting Impact Assessment Studies of CSR projects undertaken by NIACL.

2. The Bidders shall furnish the bid only by the way of e-tender via the e-procurement portal www.tenderwizard.com/NIAEPROC by or before the bid submission deadline. No other mode of submitting tender is allowed.
3. The last date and time for submission of RFP is 29th April 2024 up to 2:00 pm. RFP will be opened on 22th April 2024 at The New India Assurance Company Limited, Mumbai after 2:00 pm. RFP submitted after last date will not be entertained and shall be rejected henceforth. Decision of NIACL in this regard shall be final, conclusive and binding on the applicants and NIACL takes no responsibility for any delay whatsoever.
4. NIACL reserves the right to cancel the RFP partly or fully at its sole discretion at any stage without assigning any reason to any of the participating bidders.
5. NIACL reserves the right to reject any or all Bids without assigning any reasons.
6. NIACL also reserves the right to modify the terms and conditions and also to cancel the bid process at any stage without assigning any reasons.
7. The RFP shall be valid for at least 180 days from the last date of submission.
8. The applicant Companies/ Firms/ Agencies are required to enclose photocopies of the following documents duly self-attested, along with the RFP, failing which their RFP shall be summarily out rightly rejected and will not be considered.
 - a. Copy of valid registration under Companies Act/ Registered Firm/ Proprietorship/ Cooperative/ Societies Registration Act/ state/ central Govt. authority in India/ any other,
 - b. Copy of PAN Card,
 - c. Copy of the GST Registration Certificate,
 - d. Copy of the IT return filed for the last three financial years, and
 - e. RTGS/NEFT Detail (Bank Details).
9. NIACL will not enter into any correspondence with the bidders except to furnish clarifications on the RFP and RFP documents, if necessary. All clarifications need to be submitted in writing, at email id ani.sharma@newindia.co.in , addressed to the issuing authority of this RFP. Last Date for submission of queries*/ request for clarification from bidders through email is 26th April 2024 by 4:00 pm (NO queries will be accepted On telephone or through any means Other than email).
10. Scope of empaneled agencies would be as follows:

- a. To study the direct/ indirect impact of the CSR projects on the lives of communities/ people in areas where the project is carried out including the study of number of beneficiaries covered, improvement in their socio-economic conditions etc.
- b. To study the level of awareness of CSR projects/ initiatives amongst the target beneficiaries/ concerned stakeholders.
- c. To study the consistency in the process of project implementation together with fulfillment of stated objectives.
- d. To identify gaps and pain areas.
- e. To study beneficiary's involvement in the suggested projects.
- f. To study the entire implementation of projects and recommendations for improvements.
- g. To produce a high-quality impact assessment report for future reference.
- h. To do financial audit of the NGO including:
 - i. List of major donors, ii. Any other contributor to the CSR project, and iii. Summary of the NGO's Income and Expenditure statements.
 - i. Financial study of the grant rolled out by NIACL.
 - j. The data for same may be collected from:
 - a) Primary sources: implementing NGO/ Society/ Trust, targeted beneficiaries, community representatives/ PRIS and Govt. officials etc.
 - b) Secondary sources: DRDA, Project implementing Agency, NIACL etc.

The above list is indicative not exhaustive.

The detailed scope of work for each study/ assignment will be stipulated while calling for financial bid for concerned CSR project from the empanelled agencies.

- 11. Our Requirement:** NIACL requires RFP from agencies as per the scope (defined in point no. 6) and conditions (defined in point no. 13) attached.

12. Selection process:

- 1) Submission of RFP along with technical proposal by Eligible Agencies.

- 2) Top Four Agencies who qualify in technical proposal will be issued an "in-principal" approval for empanelment with NIACL for three years.
- 3) Financial proposal/ bids will be invited from the empanelled agencies (as and when required by NIACL)
- 4) Financial proposals/ bids will be evaluated and work allotment will be made to 1--1 Agency.

13. Conditions for Empanelment:

- 1) NGOs/ Voluntary Agency/ Public Trust/ Agencies which are having at least 05 years of experience of working preferably with State Governments/ Government of India, agencies such as UN/ bilateral/ multi-lateral funding/ partner agencies and corporates including CPSEs in social development sector with valid registration/ recognition from state/ central Govt. of India.
- 2) Should have valid registration under Companies Act/ Registered Firm/ Proprietorship/ Cooperative/ Societies Registration Act/ state/ central Govt. authority in India/ Any other (please provide self-certified copy of the registration certificate).
- 3) Should have valid PAN and GST registration number (please provide self-certified copy of the registration certificate).
- 4) Black listed Agencies by any State Government/ Govt. of India/ Corporate(s) or any funding/ partner Agency will not be entertained. They should not have any pending legal disputes.(Declaration as per Annexure II)
- 5) The Agency should have experience in conducting impact evaluation of projects implemented in the field of sanitation, skill development, health care, livelihood generation, rehabilitations, education, etc.
- 6) Should have conducted at least 05 impact evaluation projects for PSUs/State Governments/ Government of India, agencies such as UN/ bilateral/ multi-lateral funding/ partner agencies and corporates including CPSEs in social development sector with valid registration/ recognition from state/ central Govt. of India in each of the last three Financial Years i.e. FY 2021-22, FY 2022-23 and FY 2023-24.
- 7) The agency should have provided at least 2000 — man days of consultancy in each of the last three financial years i.e. . FY 2021-22, FY 2022-23 and FY 2023-24.
- 8) Should have offices in at least three states/ UTS of the country.
- 9) Agency should not sub-contract any work to other Agency.

14. Conditions for RFP:

- a. NIACL shall have the sole right to decide on the rejection Of the participating agency on the basis of technical qualifications, without entertaining any correspondence or queries or giving explanation to any of the participants or any other parties in respect of the selection process and also to exclude them on the basis so decided by NIACLto participate in the financial bid.
- b. Conditional offer/ RFP shall not be considered and shall be liable for rejection.
- c. It is reiterated that NIACL reserves the right to accept or reject the RFP without assigning any reason whatsoever and that NIACL is not bound to accept any orall RFP which it may receive. NIACL may also decide not to avail of services from any applicant. NIACL also reserves the right to re-issue/ recommence the entire process without the applicant and/or other vendors having the right to object.
- d. The applicant should read and understand the terms and conditions of the RFP before applying as submission of the RFP shall be deemed to signify the acceptance of all the terms and conditions and the annexures forming part and parcel of it.
