1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

- 1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
- 2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior

written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

IMPORTANT NOTES FOR BIDDERS-

- 1. Bidders shall thoroughly go through the Bidder Qualification Criteria, Instruction to Bidders and Scope of work.
- 2. All declarations as per Instruction to Bidders shall be submitted.
- 3. Audited balance sheets and profit and loss statements, breakup for capital, statements of surplus and reserves for last three consecutive financial years shall be submitted (FYs ending on March 2021, 2022 and 2023)
- 4. While bidding price in tender, it shall be inclusive of all taxes and duties. Bidder shall refer the quantities given in BOQ (mentioned in scope) and quote prices for entire quantity.
- 5. L1 shall submit all technical and financial documents with TPIA verification.
- 6. Past experience requirement shall be as per BQC
- 9. Payment term and LD- As per BPCL scope and GCC
- 10. BPCL GCC shall supersede the GEM GTC.
- 11. Successful bidder shall be issued with BPCL contract copy. BPCL has digital system of Digital Invoice Management (DIM) and Electronic Measurement Book (E-MB) for billing and measurement submission process. Successful bidders shall get themselves registered on DIM through the link https://econnect.bpcl.in/. The bidder shall use E-MB application (only for works/service contracts) for submitting the job measurements for approval to Engineer In-charge. Help documents for these processes shall be shared with successful bidder along with the BPCL PO copy.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
