## Terms and Conditions

1. Rate: The charges quoted shall be firm and final which includes service charges, and labour cost etc. The job must be thoroughly inspected prior to quoting. The rate quoted must include cost of the inspection of Crane & submission of report.

## 2. Bid Evaluation:-

The bid consists of two cover.

Cover-1 - should consist of following documents except price value.

- 1. Notarized copy of valid license issued by Insurance & Regulatory Development Authority of India (IRDAI) under "Marine Hull & Engineering Equipment & Machineries and Equipment Surveying" category.
- 2. The bidder should have completed similar work during past seven (07) years. Notarized copy of work order fulfilling the similar work experience should be furnished.

Similar work means "Valuation of Electrical Level Luffing Grab Crane" or "Valuation of ELL wharf cranes / Mobile cranes / Quay Cranes" or "Repair & Maintenance of ELL Wharf Cranes / Mobile Cranes / Quay Cranes"

3. Notarized copy of GST No. & PAN card Number.

## Cover - 2

The bidder shall quote the price as per the price schedule format enclosed. The cover shall be sealed and embossed as cover-2.

- 3. <u>GST:</u> The Rate of GST shall be quoted separately GST shall be paid to the service provider only on submission of necessary proof of payment or after reflection in the GSTR2A as eligible ITC (Input Tax Credit).
- 4. Location: 20 T Electrical Level Luffing Grab Crane, V.O Chidambaranar Port Authority located at Thoothukudi in Tamil Nadu. Transport arrangement and Boarding etc shall be arranged by the firm at their own cost for the inspection of the Crane.
- 5. Inspection & Submission of Report: Valuation report has to be furnished as per accepted professional standard in a printed form with color photography on completion of inspection. Schedule of visit may be intimated to the Port well in advance for making arrangement for inspection.
- 6. <u>Work Completion period:</u> Work shall be carried out within 30 days on receipt of the work order. Failing which LD will be imposed.

- 7. Liquidated Damages; If the contractor fails to complete the work in all respects within the time specified, the contractor shall pay or allow the board to deduct a sum equivalent to 1% per week or part thereof on the total value of the contract subject to a maximum of 10% of the total value of contract as liquidated and ascertained damages and not by way of penalty, for every week or part thereof beyond the said period or extended period as the case may be during which the work shall remain unfinished. Such damages will be deducted from any money due or become due to the contractor. The payment of such damages shall not relieve the contractor of his obligations to complete the work or from any other of his obligations or liabilities under this contract.
- **8. Payment:** 100% payment will be made on submission of bills along with valuation report to the entire satisfaction of Port authorities. The bill, in triplicate, should be submitted to undersigned along with Advance Stamped Receipt for making payment.
- 9. Income Tax: Income Tax on the rate, as applicable, will be deducted from your bills. The PAN should be furnished in your bill, failing which; no payment will be made till such time the same is received in this Office.
- 10. <u>General:</u> If the work is not completed within the completion period, the Port has the right to withdraw the work and entrust the same to the other party.
- 11. <u>Right</u>: The Chief Mechanical Engineer, VOC Port Authority reserves the right to accept or reject any tender in full or part without assigning any reasons.
