- 1. The items for sale are as per the list attached at List of Items uploading in e-tendering website www.eprocure.gov.in. The bidder has to quote in Lumpsum amount for these items on as is where is basis.
- 2. Before quoting, the bidders to ascertain the Quality, Quantity of items as per the List of items through the site visit as per the timelines mentioned in Notice Inviting Quotation. No queries related to Quality and Quantity of items after the opening of bid shall be entertained.
- 3. Bidders to submit the quotation in Hard copy in sealed envelope on or before last date and time of submission of bid along with the following documents:
 - a. DD for EMD as per NIQ.
 - b. DD for Security Deposit as Per NIQ.
 - c. Pan Card of firm/ Owner
 - d. GSTIN Certificate of Firm
 - e. Aadhar Card of Owner
 - f. Lumpsum Quotation of bidder (in the format as provided by NBCC)
- 3. The bidder to consider the manpower/machinery for lifting, freight charges, accommodation charges and other statutory charges whatever required for pickup and transport of items to contractor's/bidder's location. NBCC shall not bear any charges in this regard. Any charges incurred by the bidder for disposal of electronic items shall be borne by bidder only.
- 4. The Quoted amount are excluding GST. GST shall be charged extra as per prevailing GST rates. For any increase/ decrease in GST rates same shall be adjusted prospectively for contract. Any other tax if levied by authorities shall be borne by the Purchaser/bidder. TCS 1% on quoted amount shall be collected as extra.
- 5. The time of contract for collecting the items is 15 days which shall be reckoned from the 5th day of placing Letter of award to the successful bidder.
- 6. The bidders to submit the Earnest Money Deposit @1% and Security Deposit @10% as per the Notice Inviting Quotation in the form of Demand Draft in Favour of NBCC (India) Limited along with bid.
