**TERMS AND CONDITIONS FOR E-AUCTION OF THE UNSERVICABLE MATERIAL AND PLANT MACHINERY AT VERKA FEROZEPUR DAIRY**

1. Auctioning of the unserviceable material and plant machinery at Verka Ferozepur Dairy shall be done through E-tender processing and the financial bids of those eligible parties will be opened completing or conforming with the terms under the technical bid.
2. Interested men or parties shall deposit a sum of Rs. 20,000/- as Earnest Money (EMD) through online portal on eproc.punjab.gov.in in the name of THE FEROZEPUR DISTT. COOPERATIVE MILK PRODUCERS UNION LTD. FEROZEPUR. The already deposited security money shall not be considered as the Earnest Money. After the completion of the tendering process, the EMD of the unsuccessful bidders will be returned. Earnest money deposit (EMD) of the successful tenderers/bidders shall be deposited in the form of security deposit. Any kind of interest will be paid on the Earnest Money Deposit (EMD).
3. In case of withdrawn of bid/tender by the successful tenderer, the Earnest Money of the successful tenderer/bidder will be forfeited in full.
4. The quantity/amount of any unserviceable material or plant machinery may be decreased or increased subjected to the availability of the material at Verka Ferozepur Dairy.
5. Scrap will be auctioned on **"As It Is Where It Is"** basis.
6. Sales tax/GST/Income tax and other kind of taxes on the unserviceable material and plant machinery shall be paid by the successful tenderer/bidder. The tenderer/bidder shall be equipped with GST and PAN number.
7. Aluminium cans, drums and AI Container shall be lifted by the successful tenderer/bidder only after the cutting into pieces.
8. The minimal rates of the unserviceable material and plant machinery are already set by the Verka Ferozepur Dairy (List Enclosed). The scrap/unserviceable material given under the list will be auctioned lot-wise. The tenderer/bidder shall place the bid for the entire lot of the unserviceable material and plant machinery according to the enclosed list. No bid will be entertained for any particular item available in the lot. The successful tenderer/bidder shall deposit the entire amount of the unserviceable material as mentioned in the list.

Apart from the lot made, the plant machinery will be auctioned on the rate per item basis. The unserviceable material listed lot-wise will be weighed on the scale on per kilogram basis and the remaining unserviceable material will be auctioned on the basis of the rate per item.

9. The tenderers/bidders participating in the bidding process shall bid for the unserviceable material in the list keeping the minimum/reserved rates of the unserviceable material in the list. The tender will be given/placed to the tenderers/bidders having the highest bid for the unserviceable material against the minimum/reserved rates of the unserviceable material in the list.
10. All the expenses involved in the packing, weighment, loading and cutting of aluminium can etc., will be tolerated by the successful tenderer/bidder placing the highest bid for that particular unserviceable material. The lifting of the unserviceable material shall be completed within 20 days from the date of the allotment of the order. In case of non-deposition of the money of the unserviceable material in full and lifting of the unserviceable material by the successful tenderer/bidder, the tender or allotment shall be subjected to the termination and the corresponding EMD deposited by the tenderer/bidder will be forfeited in full and the tender may be allotted to the next eligible tenderer/bidder.
11. No tender/allotment will be replaced in the name of the other party by the successful tenderer/bidder for the unserviceable material allotted.
12. The unserviceable material and plant machinery may be seen from 9:00 am to 5:00 pm during the working days.
13. General Manager, Verka Ferozpur Dairy reserves the right to terminate/end allotment of any tender/or all the tenders without giving any reason.
14. Before lifting the unserviceable material as per allotment to the successful tenderer/bidder, all the amount/money of the unserviceable material being lifted shall be deposited in advance with Milk Union, Ferozpur.
15. To participate in the bidding process by the tenderer/bidder, the documents required under the technical bid like: Aadhar Card/Identity Card etc are mandatory to be submitted by the tenderer/bidder along with passport size photos and the address shall be enclosed with it. The tenderer/bidder must be equipped with these documents on the day of opening of the bids at Verka Ferozpur Dairy for the verification.
16. General Manager, Verka Ferozpur Dairy reserves the right to add/remove or any change regarding the dates/terms and conditions

of the tender of the unserviceable material and plant machinery at Verka Ferozepur Dairy.

17. Any kind of remaining taxes and transfer charges regarding vehicles under the unserviceable material list will be paid by the successful tenderer/bidder.
18. In the event of any difference or dispute arising out of any contract or agreement at Milkfed level/unit level /union level the same shall be referred to the Registrar, Cooperative Societies, Punjab to decide the dispute himself, or transfer it for disposal to any officer not below the rank of Deputy Registrar, Cooperative Societies, Punjab for dispute resolution by the arbitrator. The provision of the Punjab Cooperative Societies Act, 1961 and rules, 1963 as amended up to date shall apply to arbitration proceedings which shall be held in the office of designated arbitrator"
19. In case of any dispute arisen, the court for jurisdiction lies in Ferozepur only.
